KNIGHTS OF COLUMBUS 6326 Privacy Policy

This Privacy Policy ("Policy") applies to Knights of Columbus 6326 ("Organization"), located at 803 Cockerham Rd in Denham Springs, LA and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to the Organization include the Knights of Columbus 6326 located at 803 Cockerham Rd. Collection of your Personal Information

To better provide you with products and services offered, the Organization may collect personally identifiable information, such as your:

- First and last name
- Mailing address
- Email address
- Phone number

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. These may include: (a) registering for an account; (b) entering a raffle contest sponsored by us; (c) sending us an email message; (e) submitting your credit card or other payment information when ordering and purchasing products associated with a fundraiser sponsored by us. To wit, we will use your information for, but not limited to, communicating with you in relation to services and/or products you have requested from us. Use of your Personal Information

The Organization collects and uses your personal information in the following ways:

- to operate and deliver the services you have requested
- to provide you with information, products, or services that you request from us
- to provide you with notices about your account
- To carry out the Organization's obligations and enforce our rights arising from any contracts or agreements entered between you and us, including for billing
- To notify you about changes to our website or physical facilities or location
- In any other way we may describe when you provide the information
- For any other purpose with your consent.

The Organization may also use your personally identifiable information to inform you of other products or services available from the Organization.

Sharing Information with Third Parties

The Organization does not sell, rent, or lease its customer lists to third parties.

The Organization may share data with trusted partners (i.e., the Supreme Council) to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to the Organization, and they are required to maintain the confidentiality of your information.

The Organization may disclose your personal information, without notice, if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on the Organization or the site; (b) protect and defend the rights or property of the Organization; and/or (c) act under exigent circumstances to protect the personal safety of users of the Organization, or the public.

Automatically Collected Information

The Organization may automatically collect information about your computer hardware and software. This information can include your IP address, browser type, domain names, access times, and referring website addresses. This information is used for the operation of the service, to maintain quality of the service, and to provide general statistics regarding the use of the Organization's website.

Right to Deletion

Subject to certain exceptions set out below, on receipt of a verifiable request from you, we will:

- Delete your personal information from our records; and
- Direct any service providers to delete your personal information from their records.

Please note that we may not be able to comply with requests to delete your personal information if it is necessary to:

- Complete the transaction for which the personal information was collected
- Detect security incidents, protect against malicious, deceptive, fraudulent, or illegal activity; or prosecute those responsible for that activity
- Debug to identify and repair errors that impair existing intended functionality;
- Exercise free speech, ensure the right of another consumer to exercise his or her right of free speech, or exercise another right
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics
- Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us;
- Comply with an existing legal obligation; or
- Otherwise use your personal information, internally, in a lawful manner that is compatible with the context in which you provided the information

Children Under Thirteen

The Organization does not knowingly collect personally identifiable information from children under the age of 13. If you are under the age of 13, you must ask your parent or guardian for permission to use the website https://KofC6326.org.

Email Communications

From time to time, the Organization may contact you via email for the purpose of providing announcements, promotional offers, alerts, confirmations, surveys, and/or other general communication.

Changes to This Statement

The Organization reserves the right to change this Policy from time to time. For example, when there are changes in our services, changes in our data protection practices, or changes in the law. When changes to this Policy are significant, we will inform you. Your continued use of the website and/or services available after such modifications will constitute your: (a) acknowledgment of the modified Policy; and (b) agreement to abide and be bound by that Policy.
